

Company Overview

PERX, headquartered in Norway, is a crowdlending platform focused on bridging the gap between private and institutional investors and property-focused SMBs.

Founded with a vision to revolutionize peer-topeer lending, PERX began its journey offering unsecured consumer loans. However, faced with shifting regulations and a maturing market, they successfully pivoted to serve the real estate and business lending sectors.

With a small but agile team, PERX has captured a remarkable 25% share of Norway's crowdlending market. Their ability to adapt quickly has set them apart, and their technology stack—anchored by Symphonix—has been a key enabler of that agility.

The Challenge

PERX faced a uniquely complex path to growth:

- Regulatory Uncertainty: Originally focused on unsecured consumer lending, PERX had to pivot twice due to evolving government regulations—first toward collateral-backed loans for individuals, and eventually to loans solely for businesses.
- Changing Product Strategy: As investor

- confidence shifted, PERX had to adapt its loan offerings to align with market preferences.
- Resource Constraints: Operating with a lean team, PERX needed a platform that could do more with less—offering flexibility, customization, and automation without excessive headcount.

The Solution

To stay nimble in the face of change, PERX relies on Symphonix's Origination and Servicing modules. Their use of the platform enables them to:

- Launch and modify loan products quickly in response to regulatory changes
- Administer a growing loan book with a small operational team

While PERX uses its own custom-built frontend application (developed and maintained by CloudKaptan), Symphonix handles the core backend automation and compliance logic.



The Implementation

As product demands changed, their small internal team, supported by CloudKaptan, adapted quickly—often making key changes within days. Their platform supports manual overrides where needed, while still offering paths toward full automation.
